

Entrepreneur Visa (D2)
Portugal





### Overview



The D2 visa is appropriate for entrepreneurs, freelancers, and independent professionals who want to get involved with commercial activities in Portugal and the wider EU.



Different available options for this category of residence visa include incorporating a company or investing in an existing business entity.



It is a residence visa normally issued by the Portuguese Embassy in the country of origin, followed by a long term residence permit issued in Portugal.



# **Basic Requirements**

Professional profile

Business plan

Active health insurance in Portugal

Certificate of criminal record

Verification of economic means to maintain and develop the business

Proof of accommodation in Portugal

**Note:** The incorporation of a company will imply monthly costs, such as social security, accounting, work insurance(s), taxes, and other potential costs inherent to the area of activity.

#### Procedure

- Approval of shareholders eligibility
- Preparing a business plan
- Incorporating a new company
- Obtaining necessary licenses & permits
- Opening a bank account
- Transferring the initial capital share
- Registering at tax and social insurance
- Payment of all standing dues from the day of company registration
- Transfer of Guaranteed Minimum Monthly Remuneration (GMR) for each shareholder/director.
  - EUR 9120 for the main applicant

EUR 4560 – for the spouse

EUR 3040 – for each child

- Entering Portugal with the special residence visa issued by a Portuguese Consulate
- Attending a final interview at SEF to evaluate character and competency.
- Staying in Portugal for 183 days per annum to be eligible for permanent residency after 5 years.

Note: Immediately upon incorporation of the company certain costs will become payable by the owners. These expenses include social security, accounting, work insurance, taxes, and other potential costs inherent to the area of activity.
