


Digital Nomad Visa

Portugal





Overview

The Digital Nomad Visa is designed for foreign remote workers and freelancers seeking to reside in Portugal while performing their jobs from afar. The Residence Permit has an initial validity of 1 year. At the end of the first year, it can be renewed for another year, if the requirements are maintained. After 5 years of legal stay in Portugal, the applicant can apply for permanent residence and at a later stage for citizenship.



To qualify for Portugal's Digital Nomad Visa, applicants must exhibit a consistent and reliable income from international sources, substantiating their financial capacity to reside in Portugal. The minimum income thresholds differ based on the number of family members applying:

The Main Applicant: Four times the current minimum wage in Portugal that is 3040 EUR/month or 36480 EUR/year. **Spouse:** Approximately 50% of the minimum monthly income of the main applicant that is 1520 EUR/month or 18240 EUR/year.


Dependent Children: Approximately 30% of the minimum monthly income of the main applicant that is 912 EUR/month or 10944 EUR/year for each child. Family of two: EUR 4560 per month / Family of three: EUR 5472 per month / Family of four: EUR 6384 per month

Procedure

The applicant has to submit the application with all the necessary documentation at the Portuguese Consulate. After the analysis and approval, an initial visa will be issued, allowing the applicant to travel to Portugal.

Then an appointment will be scheduled with the Portuguese Immigration Authority (AIMA) to present the visa and deliver some complementary documentation during a personal interview. Consequently, a Residence Card will be issued for the applicant.

The residency status with all its rights also extends to immediate family members including spouse and dependent children.



Minimum Stay

The applicant needs to be present in Portugal for a period of 6 consecutive months or 8 intermittent months during the period of validity of the residence card. If the holder intends to be absent from Portugal for a period longer than these, he/she must communicate this to AIMA before leaving national territory.

Main Requirements

1. Proof of fiscal residence

2. Proof of having the threshold monthly income for at least 3 months

3. Work or Service provision contract or document demonstrating the services rendered to other entities

- 4. Authorization to AIMA for the Portuguese criminal record
- 5. Certificate of clear criminal record from country of origin
- 6. Valid health insurance in Portugal
- 7. Proof of accommodation i.e., long-term rental or owned property in Portugal

8. Portuguese Bank Statement with minimum EUR 9120
