# Overview



The Entrepreneur / Self-employed visa is appropriate for businessmen who plan to develop an entrepreneurial activity or to start, develop or direct an economic activity in Spain.



The business idea should generate wealth and employment for Spain and be innovative as well.



Although there is no minimum threshold for a business activity, the amount of investment should typically be between hundred to five hundred Euros.



The application for the Entrepreneur / Self-employed should be made at the Spanish Consulate in the country of origin. The applicant will then be able to live and work in Spain for a period of one year. Thereupon the permit will be renewed for 2-year periods.

- Professional profile

- Active health insurance in Spain

- Business plan

- Verification of economic means to maintain and develop the business.

- Added value to Spanish economy

- Certificate of criminal record

# Procedure

- Approval of shareholders eligibility
- Preparing a business plan
- Incorporating a new company
- Obtaining necessary license & permits
- Opening a bank account
- Transferring the initial capital share
- Registering at tax, social insurance and any other relevant department
- Payment of all standing dues from the day of company registration
- Transfer of minimum financial requirement for each shareholder/director.
  - EUR 30,000 – for the main applicant
  - EUR 10,000 – for each dependent
- Staying in Spain for 183 days per annum to be eligible for permanent residency after 5 years.

**Note:** Immediately upon incorporation of the company certain costs will become payable by the owners. These expenses include social security, accounting, work insurance, taxes, and other potential costs inherent to the area of activity.
